**Consent and Release**

For good and valuable consideration, the receipt and sufficiency of which I hereby acknowledge:

**1. Media**

I agree that Skate Canada and its members, including Whistler Skating Club, may photograph, film and/or otherwise reproduce my (or my child's) likeness and/or voice in the course of my enrolment and participation in programs and events conducted or sponsored by Skate Canada or Whistler Skating Club (the "Reproductions"). I acknowledge and agree that Skate Canada or its designate will own all worldwide right, title and interest in and to the Reproductions.

I hereby irrevocably grant to Skate Canada, its licensees and assigns, the right to utilize the Reproductions in any and all manner and media, now known or unknown, through the world in perpetuity. I agree that the Reproductions may be edited in Skate Canada's sole discretion and may be used with or without my name associated with them. I expressly release Skate Canada, its members, directors, agents, employees, licensees and assigns from and against any and all claims which I have or may have, whether known or unknown, for invasion of privacy, misappropriation of personality, defamation or any other cause of action arising out of the use of the Reproductions.

Further, I give permission for Whistler Skating Club to publish, in any form of distribution, any photographs, in whole or part, modified or altered of my child taken during a Whistler Skating Club event (including sanctioned competitions).

I hereby forever release and discharge Whistler Skating Club or its photographers from any and all claims, actions and demands arising out of or in connection with the use of said photographs, including, without limitation, any and all claims for invasion of privacy and libel. This release shall inure to the benefit of the assigns, licensees and legal representatives of Whistler Skating Club or its photographers.

**2. Liability**

The skater, or if the skater is under 18 years of age, the skater and the parents/guardians agree: The skater skates at his/her own risk. The skater will not hold the Whistler Skating Club and its professionals, employees or directors responsible for any loss or damage sustained through injury to the skater, or other skaters on or off the ice or any other liability loss, damage or expense incurred as a result of the skater attending the Whistler Skating Club programs 2012/13. The skater will abide by the rules of the Club and Skate Canada.

**3. Emergency Consent**

The following authorization is required for emergency situations in the event the parent or emergency contact cannot be reached. I/We hereby give consent for my/our child, if he/she is deemed to require immediate medical care, to be taken to the Whistler Health Care Centre. Further, in the event that I/We cannot be reached, I/We hereby authorize the health practitioner on duty to provide emergency treatment, including emergency surgery, deemed medically necessary for the physical well being of the child.

**4. CanSkate or Pre-Power Program Assistants Agreement**

Any eligible skater who has or will participate in CanSkate Program Assistant Training is required to volunteer for no less than 1.0 hour/week (this may include a few minutes before and/or after the session for set-up or clean-up). Program Assistants who are ill or unable to work a scheduled shift are responsible for finding and confirming their own replacement. Program Assistants will be rewarded \$5 per hour in gift certificates for each hour volunteered. Your assistance is greatly appreciated by the young skaters, their parents, the WSC Board of Directors and the coaches!

**2. ICE POLICIES**

**POLICY #8 – FREESKATE SESSIONS**

- a. Soloists have the right of way. Other skaters must avoid undue interference with the soloist, and the soloist must keep an alert eye open.
- b. When the jump harness is in use, the skater in it has the harness right of way over the soloist.
- c. Spins should be done towards the middle of the ice and jumps to the perimeter.
- d. Solo CDs may be played twice per session, time permitting according to the music player’s skate order. If a skater refuses their solo, it will be played after the others on the session, including buy-ons.
- e. Buy-on skaters music may be played after full-time skaters music has completed one cycle.

**POLICY #9 – GROUP ENRICHMENT**

- a. All skaters are required to take part in the group lessons if it is included in their session.
- b. All skaters are required to take part in off-ice sessions for their level.

**POLICY #10 – DANCE OR SKILL SESSIONS**

- a. Skaters in a lesson with music have the right of way.
- b. Skaters practicing with music have the second right of way.
- c. Free skating is not permitted.

**POLICY #11 – ALL SESSIONS**

- a. Appropriate skating attire must be worn.
- b. No swearing, temper tantrums or inappropriate behavior during on or off-ice sessions will be tolerated.
- c. Instructors/coaches have the right to dismiss skaters for lateness or inappropriate behavior.
- d. Do not stand or coast in the middle of the ice. Be aware of fast moving skaters.
- e. Skaters must get up promptly after a fall, unless seriously injured.
- f. Skaters must commit to an energized work ethic that enhances skater development.
- g. Promote good sportsmanship by encouraging fellow skaters and respecting their work time on the ice.
- h. Once the Olympia doors are opened skaters must clear the ice for the ice clean.
- i. Do not play or fool around in areas used for pre-ice warm-up.

**POLICY #12 – PARENT VIEWING AND COACHING**

- a. Parents are permitted in the bleachers and lobby only. No parents will be permitted to remain on ice level.
- b. Parents are not allowed to coach, teach, lecture or encourage at the rink boards or from the music room. Interrupting focus during a moving session is considered hazardous.
- c. Parents are requested to not speak to coaches on the ice nor delay their arrival to ice or off-ice sessions.
